Generation Schools:

1. Charged per candidate, per subject.
2. Private candidates are charged an admin fee to cover their registration with Cambridge International.
3. Charged per practical, per subject.
4. Sciences include separately billable subjects, papers and practicals relating to the following:
 - Physical Sciences [IGCSE]
 - Chemistry [IGCSE and AS/A Level]
 - Physics [IGCSE and AS/A Level]
 - Biology [IGCSE and AS/A Level]
5. After the final entry closing date, we will charge late fees for any new entries you make, as well as for any entry amendments or syllabus changes. Entries or changes received after the published deadlines can cause disruption to carefully scheduled processes and cause significant additional work. Late entry fees are therefore applied to recover the costs of additional processing requirements, and to encourage the submission of entries by the advertised closing dates. Late entry fees will be charged in addition to the normal syllabus fee. Cambridge International may be unable to accept entry changes in the very late entries period if these are received too close to the exam.
6. Courier costs relating to the sending/return of art are based on items being returned by courier and on work being a maximum size of A2. There may be an additional postage charge if the maximum size/weight is exceeded.
7. A quote relating to your child/ren's estimated Cambridge examination fees will be sent at the beginning of the school year for payment. Please note that this is only an estimate and may not be the final examination costs due to various changes that may occur during the academic year, e.g. subject changes. It is encouraged that this quote is paid as early as possible to avoid financial pressure prior to the final submission date to Cambridge International.
8. Examination fees to be paid into the same bank account of the school/campus that the candidate attends, using the same reference assigned for school fees i.e. 'Child Name & Surname'.
9. Private candidates are to pay their examination fees into the bank account of the campus they will be writing. Please use your 'Child Name & Surname' as the reference.
10. Examination fees to be paid in advance of Generation Schools' submission of entries to Cambridge International.
11. In the event that examination fees are not paid in time to Generation Schools' based on the published submission date, the prospective candidate will not be registered for their relevant examination entries.
12. Where prospective candidates have outstanding fees on their school account, any monies paid towards examination fees will be utilised against outstanding school fees first.
13. We only refund fees if you let us know about the withdrawal of a candidate before the published entry closing date. We issue refunds after the end of the examination series.
14. All quotes given will be subject to fluctuations in the foreign exchange rate. Due to the nature of the Pound:Rand exchange rate, an adjustment may be required during the year, in which case an extra invoice may be sent to candidates.
15. Examination fees for Generation Schools candidates as well as private candidates written at Generation Schools is valid between January 2022 to November 2022.
16. If specialist access arrangements are requested for which Cambridge approval is required, this is by arrangement only and is dependent on our capacity. Additional invigilation and arrangement costs may be incurred. Please contact us directly at the time of entry for details.
17. Date for full payment of the examination fees into the Generation Schools' bank account (same as school fees) will fall due and payable on the invoice date.
18. An invoice for entry will be emailed to you for careful checking. Please notify us via email of necessary amendments immediately on receipt of the invoice. We cannot be held responsible for entry errors that should have been identified by you. Errors requiring amendment which are identified after the schools Cambridge International submission date will incur the late penalty fee so please inform us before that date.
19. Please refer to the Generation Schools Cambridge subject list for the subjects that are offered as exam opportunities.

Cambridge Associate Schools

20. The "Admin Cost (charged per paper NOT per subject)" and "Private Candidate Registration Admin Fee" is waived in favour of the Associate School. All other relevant fees are payable.
21. Associate Schools are to courier their examinations to the closest GenEx/Generation Schools site, at own cost, for bulk consignment to Cambridge.
22. Costs to facilitate the exam sitting(s) at respective Associate Schools and courier examinations to GenEx/Generation Schools site are borne by the Associate School, i.e. invigilation, courier costs, venue setup, etc. Associate Schools may charge their own "Admin Fee" to their candidates to cover these expenses.
23. Associate School cannot offer subjects with coursework components if they are not an exam centre per Cambridge requirements (not able to verify work). Only if an Associate School is an exam centre can it offer subjects involving coursework.
